Dues Clarification

The Rotary Club of Fairhope Fiscal Year runs July 1 through June 30. For example, Fiscal Q3 runs January 1 through March 31. Dues are billed quarterly in advance and should be paid within the first 30 days of the quarter. Currently, dues are \$275 per quarter and include meals. New club members will have additional items added to their statement depending on what quarter of the year they join the club. All new members will be required to pay an Initiation Fee of \$100. (May 2, 2012)

Dues: \$275 per Quarter

Dues are \$275 per quarter which adds up to \$1,100 per year. Dues paid for a full year include the following items: Rotary International dues, The *Rotarian* magazine, RI Council on Legislation assessment, RI Club insurance policy fee, District 6880 dues, club dues, meals, Every Rotarian Every Year (EREY),* four (4) Steak Cook-off tickets,† and a deposit to the Club Reserve Fund.

EREY, steak tickets, and Club Reserve Fund are incorporated depending on the quarter. The Q1 bill includes the EREY contribution to The Rotary Foundation. The Q2 and Q3 bills include steak tickets. The Q4 bill includes the Club Reserve Fund.

* EREY: Every Rotarian Every Year contribution to The Rotary Foundation counts towards Paul Harris Fellow points and is tax deductible. You will receive a receipt in the mail from the Foundation.

† Fairhope Rotary's Annual International Steak Championship Cook-off for Charity is always held the second Friday in May and is the major fundraiser for the club. See <http://www.fairhopesteak.org> for more info.

New Member Bill for Joining Quarter

Q1: \$375 = \$275 for Regular Member Quarterly Dues + \$100 New Member Initiation

Q2: \$475 = \$275 for Regular Member Quarterly Dues + \$100 New Member Initiation + \$100 for Every Rotarian Every Year (EREY) to The Rotary Foundation

Q3: \$575 = \$275 for Regular Member Quarterly Dues + \$100 New Member Initiation + \$100 for Every Rotarian Every Year (EREY) to The Rotary Foundation + \$100 for Q2 Steak Cook-Off tickets

Q4: \$675 = \$275 for Regular Member Quarterly Dues + \$100 New Member Initiation + \$100 for Every Rotarian Every Year (EREY) to The Rotary Foundation + \$100 for Q2 Steak Cook-Off tickets + \$100 for Q3 Steak Cook-Off tickets‡

‡New members joining in the month of April are required to buy Steak Cook-Off tickets. New members joining in the month of May or June are not required to buy Steak Cook-Off tickets and will be billed \$475.
